It was a struggle to get the first student in the door. We attended the Oktoberfest that the town hosted in 2003. We got our first students from that event. The Johann Family that owned Westside Towing at the time and the Denhards, who still help light the Star each year. They trusted us with their kids and we had our first students! We have watched their kids grow up with us to become Pilots, Business Owners, and defenders of our Country in the US Navy.

We have learned through hard work and dedication that we can achieve our dreams. We continued to grow through the years and beginning in 2004 received the award for Best Martial Arts Academy in Castle Rock. Over the years we have gone on to receive that award 12 times. This town and our business have created a wonderful life for our family. Our son is has grown up in the Academy and it is his favorite place to go since he always gets to see his friends! In March of 2020 we were at the height of our business and things looked like we were going to have a record year. Then the bottom fell out. Our PPP grant was only 1/3 of what it should have been. 1st Bank said "Take it or Leave it." There are no other jobs. Martial Arts is what we do. It is ALL we do. Anyone who runs a small business knows that there is no off time.

After 17 years serving Castle Rock we have also served thousands of families, including Town Councilmen Bower his family and Town Council woman Johnson's family. I say this because Castle Rock Martial Arts has strived to give to every family that has walked through our doors over the past 17 years a lasting memory that helped change their lives for the better. Now I am asking for the Town of Castle Rock to give to Castle Rock Martial Arts in this time of need. We are a service based business so our Sales Tax revenue to the town may not be as much as others. I can say that Castle Rock Martial Arts has tried to contribute to the Town in other ways. With set up and tear down of Outdoor events. We loved working with Terri Goudy and Angie Vencill! We have participated in downtown events throughout the years and more. There are so many businesses struggling to survive in 2020. There are many who have not made it. Hello and thank you for your time. First I would like to thank you for including our business Ronin Tattoo in the third round of grants. This means a lot and to have support from a town I have Personally worked in for almost decade. We are grateful and humbled to have been chosen whether it be options 1-2a. I do believe we should qualify for a higher threshold. In the personal service industry we depend on being able to hit a certain volume of clientele and as I have read the criteria per the point system in which amounts are determined I will break down how and why our business has been deeply effected. We were forced to close for 2 months. We were unable to perform services of any kind. We did have to continue to pay all overhead including Rent and NNN which totaled 4464\$ also We continued to pay our communication and website services which totaled 1300\$ This includes seo services, advertising and internet and phone. Not including gross take and profit lost we were out almost 6000\$ this coupled with having to support our personal overhead ie. rent, utilities, food was a big blow. Basing these next numbers off of averages from the previous year in the same industry in credit card sales alone during March and April for just one of the artists totaled close to 10,000 \$ so If you were to multiply this by 3 for the total number of employees it would be around 30,000 \$ summer and spring are usually busier times a year for our industry. Now with winter upon us and growing number of cases as well as the stricter guidelines. With a lower number of patrons allowed to into the establishment at once and In Totality, it has really pushed us to insure we can work and save as smart as possible until the situation begins to curve. This also effects the bottom line as one can come to a conclusion that the less people you are allowed to provide service for the less opportunity for growth and profit become inherently weaker. We are already held to high standard of cleanliness and the costs increased as supplies become increasingly hard to get and due to the shortage the prices in a lot of areas from gloves, masks and cleaning solutions have almost tripled. Even with all this we are still pushing forward and have no plans of being anywhere but castle rock as we have a minimum of 3 more years on our lease. We love this town and are very proud of the steps it's taken to expand opportunity and to widen a growing economy which will eventually expand our customer base. I can insure you every penny of the grant awarded will be used to insure stability and longevity so we can keep doing we are passionate about for the people in this town and for ourselves. Again thank you for your time and generosity.

Dear Town Council,

Thank you so much for considering Riverwalk Dental Arts for a business grant. Our small private practice office opened January 20, 2020. As you know, this year has been full of unpredictable things. We were able to open for about 2 months prior to having to close for Covid for 9 weeks. Despite my very efforts with marketing, getting Riverwalk Dental Arts off the ground and running as expected has been a very difficult task. New dental offices typically rely on events for marketing and developing relationships within the community, and with almost all of the wonderful events that Castle Rock holds each year being postponed or cancelled we've had to rely on fliers, Google, and other forms of marketing, and we just haven't seen the patient flow we expected. It has also been difficult to get Riverwalk Dental Arts to qualify for many of the government grant and loan programs as most want at least a year of data to support the applications, and since we opened this year that often disqualifies us from the application process. As we near 2021, I am continuing every effort to propel the office forward, and I believe that we will succeed and see an improvement in growth, however, cash flow is very tight right now. Any grant awarded to us will be a tremendous help so that we can continue to provide dental care to the citizens of Castle Rock.
