RESOLUTION APPROVING A CONSTRUCTION CONTRACT BETWEEN THE TOWN OF CASTLE ROCK AND COLORADO PUMP SERVICE & SUPPLY CO. FOR THE 2021 DENVER BASIN WELL REHABILITATION AND PUMPING EQUIPMENT REPLACEMENT PROJECT, AND THE ABANDONMENT OF INACTIVE WELLS

WHEREAS, the Town of Castle Rock (the "Town"), acting by and through its enterprise, Castle Rock Water, solicited bid proposals for the 2021 Denver Basin Well Rehabilitation and Pumping Equipment Replacement Project (the "Project") for Arapahoe Aquifer Wells CR-39; CR-86; CR-73R; and CR-117; and Denver Aquifer Wells CR-72R; CR-217; CR-41; and the abandonment of inactive Well CR-31; and

**WHEREAS,** the Town will split the Project between two qualified bidders in order to complete the Project in a timely fashion in anticipation of drought conditions through the 2021 summer months; and

**WHEREAS**, the Town and Colorado Pump Service & Supply Co. (the "Contractor"), have agreed to the terms and conditions by which the Contractor will undertake the Project for Arapahoe Aquifer Wells CR-73R; CR-117; and CR-86 and Denver Aquifer Well CR-72R; as well as the abandonment of inactive Well CR-31.

## NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO AS FOLLOWS:

- **Section 1.** <u>Approval</u>. The Construction Contract between the Town of Castle Rock and Colorado Pump Service & Supply Co. in the form attached as *Exhibit 1* is hereby approved. The Mayor and other proper Town officials are hereby authorized to execute the Service Agreement by and on behalf of the Town.
- **Section 2.** Encumbrance and Authorization for Payment. In order to meet the Town's financial obligation under the Construction Contract, the Town Council authorizes the expenditure and payment from expenditure account no. 210-4250-442.40-37, in an amount not to exceed \$557,850.08, plus a five percent Town-managed contingency in the amount of \$27,892.50, unless otherwise authorized in writing by the Town.
