Proposed Election District Map Scenarios

Lisa Anderson, Town Clerk, provided an overview of the process with the Commissioners. Brittaney Murphy, GIS Specialist, presented six map scenarios for the Commissioner's review. Commissioners felt that Map 4 met all of the Charter and Election Commission requirements as well as stayed relatively even when projected growth was factored in to year 2027. Slight adjustments were made by Commissioners to Map 4 live at the meeting which reflected voter population changes. After adjustments were made, the new map was displayed and showed that Districts were within 10.5% in voter population difference well below the 15% requirement.
