WHAT IS THE REASON FOR THIS 2021 BUDGET AMENDMENT?

- To request funding for additional needs, largely Economic Development, Downtown Development Fund and one time projects in the General Long-Term Planning Fund
- Funds have been verified to be available and appropriate to be used for these recommended projects and initiatives

BUDGET AMENDMENT SUMMARY

- Total increase to 2021 budgeted revenues: **\$2,386,282**
- Total increase to 2021 budgeted expenditures: \$13,017,277

2016 – 2020 BUDGET AMENDMENTS

- The number of budget amendments varies by year depending on needs and opportunities that arise
- Additional budget amendments will be brought to Council as needed
