Staff provided the following updates:

Douglas County Art Encounters

Eric Feinstein of Otocast was continuing work to finalize the app to provide free audio tour guides to Castle Rock residents for Art Encounters in 2021-2022.

Upon removing Tatanka Ska from Bison Park from the 2020-2021 program, artist Jacob Novinger documented a few incurred damages. Staff received direction from Town staff to pay for the damages from the Public Art Fund, which cost \$181.42. Additional public art vandalism was recently noticed at Bison Park and staff will provide details.

Tribal Jam

Staff provided the update that they were still working on the de-accessioning process of Tribal Jam.

[PAC 2021-061](#)**Encore Plaza Sculpture**

The purpose of this agenda item was to provide the Public Art Commission with an update on commissioning a permanent public art sculpture for the Encore Plaza, the future community space to be located in between Town Hall and the new development adjacently south. The developer committed to contributing up to \$50,000 in to purchase the sculpture and the Town would be responsible for its future ownership and maintenance. Members discussed reviewing the previous call for entries for Tree of Wings as a starting point, as well as putting together a selection committee consisting of various representatives and stakeholders. Discussions will continue at future meetings.

[PAC 2021-062](#)**Artfest Planning**

Members discussed attending the 2021 Artfest and confirmed that they'd like to host a table. It was suggested co-organizing some type of community engagement activity with the Castle Rock Artist Cooperative as part of phase three of the Painting Positivity campaign. Members brainstormed potential ideas such as painting rocks, as well as handout materials and overall budget. Stephanie Brueggemann graciously offered to put together a list of the items that would be required for the painted rocks project. Planning will continue in August.

[PAC 2021-063](#)**Painting Positivity Campaign Project Planning Update**

The Public Art Commission Subcommittee provided an update on the planning efforts of the Painting Positivity Campaign. The subcommittee had decided to increase the dispersal of street art installation locations. Their updated plan would distribute art at a variety of park locations and facilities throughout Castle Rock. The subcommittee also confirmed prioritizing pre-postaged post cards for phase three, in addition to installing a mural at the stairway along Sellars Gulch trail and purchasing thank you t-shirts for phase two photography participants. Commission Chair Lauri Maloney expressed concern related to spending funds designated for art on non-art items.

[PAC 2021-064](#)**Public Art Planning**

The Public Art Commission continued discussing the preparations of its next public art plan. After reviewing and comparing the plans of other communities, they determined that next steps would include solidifying interview questions and schedules, along with interviewees.
