Open Issue and Candidate Committees – Financial Filings due 1st of each quarter.


Charter Amendments – Identified needed amendments for appointing Election Commission members and new Council structure.

Changes in Local Liquor Laws

Increased application and renewal fees

Eliminated distance requirement for new schools after October 31, 2018

Location Change – Fowl Line (hearing 4/19)* [*pending possession of premise]

Renewals - Yolanda's, Famous Steak House, Uncle Maddios, Rose's, Maverik, Loaf N' Jug

Amended Bylaws to reflect Hearing Officer vs. citizen board

Appointed Municipal Judge as alternate Hearing Officer

Amended Code with Statute Title changes and to set fees administratively

Changes in State Liquor Laws

Liquor statutes moved to Title 44

Fees - Lowered to reduce uncommitted reserves

3.2% Beer – No % limit and prior 3.2% licenses converted to Fermented Malt Beverage (FMB), can only sell 8am-midnight and not on Christmas

New FMB licenses - Distance requirements from schools, RLS or LLDS

Age of Servers for FMB, RLS and LLDS – 18 years old can sell and dispense without supervision

Tastings - Days and hours increased (must amend ordinance to increase)

Liquor at Charitable Events – Now allowed for auctions

Background Checks – New fingerprint process implemented
