Lisa Anderson, Town Clerk, passed out the ballots. Ballots were then returned and tallied. Anderson announced that Councilmember Bower received 5 votes and has been elected Mayor Pro Tem.

[DIR 2018-047](#) **Discussion/Direction: 2019 Meeting Schedule and Consideration of Future Work Sessions**

David Corliss, Town Manager, reviewed the proposed meeting schedule which includes retaining the December 18, 2018 regular Town Council meeting where they will also have Council photos taken. Corliss would like direction from Council if they wish to continue with the 1st and 3rd Tuesday meetings, and proposed work sessions to have staff briefings on bigger items. Corliss reviewed the proposed schedule for January through April. Corliss also proposes to cancel the January 1, 2019 meeting and the first meeting in August to enable Council and staff to attend the National Night Out.

Councilmember Loban stated the addition of work sessions is a good idea.

Councilmember Bower agreed and that he enjoys the meetings to be candid with

the department heads to get some perspective he may not ask in a public meeting. Bower asked if a work session would be added each month, or as needed. Corliss proposes work sessions for the first four months.

Councilmember Townsend asked if there is a way to move the work sessions into the dinner time portion. The amount of meetings we have are not just Council meetings. There are liaison responsibilities that are demanding. He is not in favor of adding additional meetings. They also meet fairly regularly with Department Heads, HOAs and constituents. He is wary of adding an additional meeting.

Councilmember Teal speaks in favor of the calendar proposed. Learning the issues going on right now, there is a lot of information to absorb. Worksessions should be presentations but allow Council the opportunity to have back and forth conversations. He feels it should be a forum to have a discussion with our residents.

Councilmember Loban feels we need more dialogue. Work sessions could be a mechanism to discuss an issue more in depth.

Townsend stated we also have to make this something we can do. Councilmembers also have jobs, and if time constraints are too difficult, we could keep people from being able to serve.

Councilmember Bracken challenges the work sessions being on a Tuesday.

Councilmember Teal had to adapt his schedule due to travel for work. Teal suggests Monday nights to help accomodate business travel schedules. Bracken stated it is seasonal, but this time of year Mondays are better. Loban stated he would like to be able to attend school board meeitngs which are the same time as Council meetings. Bower stated most of his liaison appointments are on the first and third weeks. Teal asked if other Boards and Commissions are on Mondays. Gray's worst day is Monday, but he would figure it out. Johnson stated her HOA meetings are on the second Tuesday. Teal proposed keeping the December 18 meeting and make a decision on the 18th and possibly delaying the start of Council meetings to hold a worksession during dinner.

Corliss stated they can do a 5-7pm work session and have Council start at 7. The current policy is ending meetings by 9:30pm with the ability to extend the meeting to 10pm by majority vote and past 10pm by unanimous vote. We would need to do a code amendment if we want to change the day or time of the meeting.

Discussion/Direction: Introduction of Council Liaison

Responsibilities (Final liaison selections scheduled for December 18, 2018)

David Corliss, Town Manager, introduced this item. Staff is not asking for any direction tonight, but will ask for decisions on December 18. Corliss gave a brief description of the Town boards and commissions.

Councilmember Loban confirmed that Council can sign up for new boards on the 18th.

Councilmember Teal spoke with Caryn taking over the Cherry Creek Water Authority as she lives in that area. Teal spoke with Bower and Gray about rotating DRCOG as the alternate and he would like to continue as the primary member of DRCOG.

Corliss asked Council if there are meeting times for boards and commissions that are inconvenient, they can ask staff to see if that time can be changed.

Teal and Bower agree that Planning Commission should have a dedicated liaison vs. rotating.

ADDITIONAL UNSCHEDULED PUBLIC APPEARANCES

ADJOURN TO RECEPTION

Councilmember Teal stated he received a lot of feedback from residents to revise the time schedule for speaking during unscheduled public appearances. Namely the three minutes is not long enough.

Councilmember Loban does not feel it has been an issue. Bower states if we can handle issues before it gets to Council we avoid issues with needing to extend the time. Townsend stated citizens are able to reach out to us, so the dialogue is happening.

Bob Slentz, Town Attorney, stated Council has latitude on how to engage citizens. Currently our Study Sessions do not allow public comment, so it would require a code change. Slentz added that abruptly changing the meeting schedule may cause issues as items are being worked on now.

Loban proposed allowing 5 minute presentations that are pre-approved the week prior. Teal is more interested in modifying the ordinance to allow public comment and a citizen discussion item to be allowed at study sessions.

Teal stated the three minutes is very generous and that we allow public comment on both readings of ordinances, where most municipalities only allow public comment on second reading.

Corliss stated we can schedule a citizen presentation now if desired. Loban wants a formal policy to allow it.

ADJOURN TO RECEPTION

Mayor Gray adjourned the meeting at 8:24 pm and invited everyone to refreshments.
