### Fire Department Report

- Chief Croom's report
  - Crew of three are currently on deployment to the Grizzly Creek Fire (Glenwood Springs).
    - The Fire Department has a Colorado Cooperator Agreement to send apparatus and firefighters when requested.
    - The fire is currently at a 78-percent containment.
  - Fire Restrictions
    - Stage 2 restrictions are now in place due to the above-normal fire conditions.
    - The forecasted conditions are expected to continue through

- December.
- Hurricane in the Gulf
  - Department's resources mobilized as part of Colorado Task Force 1 during this disaster and returned September 2.
- Fireworks show
  - The canceled July 4 fireworks' show was rescheduled to New Year's Eve (7 pm).
- Standards of Cover (annual update)
  - Includes response data, performance measures, which are part of the department's accreditation process.
  - Presentation scheduled for the September 15 Council meeting.
  - The plan will be available on the Town's website by September 10.
  - There are no significant changes this year.
- Proclamation for Fire Prevention week in October - presentations scheduled for Council.
- Tent requests
  - School District requests tent inspections/permits.
    - Requests to use large outdoor tents as classrooms.
    - The State needs to approve the requests prior to our inspection.
  - Restaurants
    - Temporary tent permits were approved through the end of the year.
  - Currently, working through issues regarding fire ratings, heaters and the surrounding walls.
- Construction permits
  - Town's permits reflect a 36-percent increase YTD (2019-2020).

## Police Department Report

- PIO introduction
  - PIO Temby introduced herself and discussed her background/experience.
- Chief Cauley's report
  - FPPA participation
    - Town Council approved a resolution approving the police department's FPPA affiliation on Tuesday, Sep. 1.
    - The plan will be effective in March 2021 for those officers wishing to join.
    - Next step is scheduling informational meetings with officers.
  - Hiring process
    - Police officer

- Approximately 120 applicants.
  - Seven candidates are in the final stages of the hiring process.
  - Hire date is scheduled in October.
- Dispatchers
  - Received 130 applications
  - Two openings with a hire date expected by end of the year.
- Suicide Awareness month (September)
  - Recent awareness event (Sep. 1) held at Festival Park.
- Traffic crashes
  - Decrease in traffic crashes - most likely due to pandemic (down 26 percent).
  - Crash levels beginning to increase slightly.
- Online crime reporting
  - Year-to-date (YTD), there has been a 50-percent increase of online reporting (2019-2020).
- Department's 2019 Annual Report was submitted our website: [CRgov.com/police](http://CRgov.com/police) (under About Police).
- One-By-One Policing
  - Chief Cauley presented the Department's One-By-One Policing philosophy at last month's Colorado City & County Management Association (CCCMA) meeting.
  - The new PIO will assist in reinforcing our message within the community.
  - Calls for police reform is a multi-faceted issue.
- Recent house fire - discussed.
- Questions for Chief Cauley regarding:
  - Increased number of aggravated assaults: yes, there was an YTD increase in percentage (6 in 2019 to 17 in 2020).
  - One-By-One Policing presentation for new public safety members: yes, Chief will plan a future presentation for the new members.
  - Philip S. Miller grant presentation: Chair Smoker, Chief Cauley and Chief Croom explained the process for reviewing applications, which will take place at the October Public Safety Commission meeting. Usually, one or two commissioners present the recommendation to Council in November.
