### DISCUSSION ACTION ITEMS

[HPB 2019-008](#) Discussion/Action: Final Historic Preservation Month Plans 2019

Angie DeLeo, Director of the Castle Rock Museum and Cindy Welch, local artist, addressed the Board requesting assistance with their Preservation Month events in May. Ms. DeLeo requested help in paying for the trolley driver and trolley tour brochures for the Museum's trolley tours on May 11. The driver's fee is \$154 and the brochure printing fee is \$225. Ms. DeLeo and Ms. Welch also requested help in paying Ms. Welch to complete a watercolor painting of the museum. The cost of the \$2,000 painting commission would include 200 postcards that would be handed out to participants of the trolley tour. The painting would be unveiled at the Museum on May 18 to coincide with other Preservation Month events. Ms. Welch would also donate 1% of any future sales of prints of the Museum painting to the Museum. Anticipating that the Board's budgeted funds would not be able to pay the entire \$2,000 painting commission, Ms. DeLeo asked the Board to consider contributing as much as possible. The staff liaison from the Public Art Commission was also present since Ms. DeLeo and Ms. Welch plan to ask for a contribution from the Commission to also help pay for the painting. The Public Art Commission will consider the request at their next meeting scheduled for April 11.

The Board discussed ownership of the painting once it is completed. Ms. DeLeo clarified that the Museum would commit ownership to the Town, but that the painting would be displayed at the Museum.

Ms. DeLeo also updated the Board on upcoming Museum events and invited Board Members to attend.

**Board Member Wimmer motioned to approve funds for the \$154 trolley driver fee and contribute \$750 towards the painting commission, with the condition that the Public Art Commission provide the remaining \$1250 and, if the Public Art Commission is not able to provide funds for the remainder of the painting commission, then the Board will provide up to a maximum of \$225 for the brochure printing fee. Vice Chair LaFleur seconded the motion.**
