Staff Presentation: Ms. Kirkpatrick presented the proposed plan for facade update to the property, this item had been continued from July 24th. The proposed changes are to include window and door replacement (openings will remain the same), a new archway, new hardy cement board to accommodate signage, new exterior lighting, and painting the existing stack stone. A new faux door will also be added to the main facade in the center where there is an existing window. Staff finds the proposal blends nicely with adjacent properties and the historic character of Downtown. The application meets Downtown Overlay District goals and criteria and staff recommends approval.

Applicant Presentation: Dave Hieronymus, Architect, presented to the Board. Owners, Kim and Aaron Fort were also present. Mr. Hieronymus presented design plans for the proposed facade updates. The proposed facade extends, slightly, in front of the property line due to the current building being built property line to property line. This has been reviewed by Public Works, who has approved the extension of 2 1/4 inches of the facade, ADA clearance has been verified. The update materials and added lighting will express downtown character and maintain context of downtown buildings.

Questions: Board Member Dickey asked if colors have been decided upon, Mr. Hieronymus does have a sketch plan but final decisions have not been made, there will be more colors than earth tones, yet still conservative.

Public Comment: None.

Discussion: Board Member Chalian really likes the look, Vice Chair LaFleur also likes the changes to the facade.

**Board Member Chalian moved to approve the facade improvements for 407 N. Wilcox Street, as shown. Board Member Fletcher seconded the motion.
