- Commission members were previously emailed a copy of the Police Department's January monthly report.
- Police Department updates
 - The Fire & Police Pension Association (FPPA) goes into effect on March 6, for those sworn officers transferring into this retirement system.
 - The 2021 Citizens Police Academy begins on April 8.
 - During the last couple of months, a new online licensing program, DocuPet, became available. It has been very successful in licensing the Town's dogs.
 - Bank of America robbery on Feb. 27.
 - Crime Alert bulletin - currently attempting to identify the two suspects.
- Questions/Comments:
 - eDiscovery and encrypted reports discussed.
 - George Floyd Justice Act is heading to the Senate - Has anyone at PD had a chance to review? Commander Gorman stated, not yet.
 - Denver Police Department's recent speed enforcement - Comment regarding the negative approach their department took in announcing the enforcement and appreciation of CRPD's positive approach (more educational).
 - CRPD's officer-involved shooting - Has the District Attorney's office made a decision on this incident? Commander Gorman is expecting the findings and review by the end of March.

month and includes an opportunity for the public to attend an open house (currently scheduled in June).
