PUBLIC ART COMMISSION SELECTION COMMITTEE

PAC 2022 -001 Town Hall Plaza Sculpture: Selection Committee to Interview Finalists

The Selection Committee interviewed three finalists for the Town Hall Plaza sculpture. Ai Qiu Hopen presented Pillars of Hope; Steven Carmer presented Hanging Cliff Side-Mirrored; Amie Jacobsen presented Still Wild. Each finalist was asked questions clarifying project details related to the designs' aesthetics, structural and foundational specifications, lighting options, etc. At the conclusion of the interviews, the Selection Committee compared the proposals and selected Still Wild for the Town Hall Plaza Sculpture project due to how the piece would fit within the site, its unique lighting features, the artist's attention to detail, the artist's successful past experience creating similar works of art, as well as the proposal's foundation requirements.

Commission Chair Jen Perry motioned and Terra Leone seconded the selection of Still Wild for the Town Hall Plaza Sculpture project and directed staff to present the recommended to Town Council for final approval. The Selection Committee voted and the motioned passed 8-0. Samantha Wood was absent during the vote.
